named in the said Will.

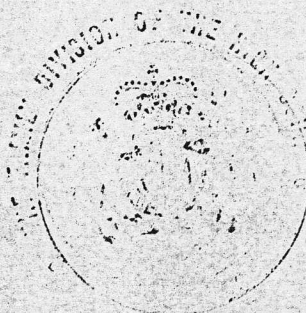

this my Will (hereafter called my Trustee) and if he shall
so act I give and bequeath to him the sum of Ten pounds
free of legacy duty. I give devise and bequeath to Obed Charles
Osborne all my interest in the premises in which I now reside
at Lanner aforesaid for his own use and benefit absolutely.
All the rest residue and remainder of my real and personal
estate whatsoever and wheresoever situate which shall belong to
me at my decease I give devise and bequeath unto my said
Trustee to hold the same upon trust in the first place to pay
my just debts funeral and testamentary expenses And after
payment thereof to hold the same upon trust for the use and
benefit of my six nephews and nieces namely Elizabeth Prouth,
Millie Rowe, Annie Williams, May Morrish, Thomas Williams and
John Williams as tenants in common in equal shares. Lastly
I hereby revoke all former wills by me at any time heretofore
made. In witness whereof I have hereto set my hand this
Second day of October One thousand nine hundred
and thirty six.
